Notes to the 2022 WZCC Financial Statements

- 1. The Global Treasurer in the U.S. maintains the global treasurer's account. The Global Treasurer compiles the Financial Statements for WZCC global entities based on the financial statements received from individual chapters or regions.
- 2. The Financial Statements for all WZCC entities are presented for the period from January 1, 2022 through November 30, 2022, except for India Region and U.K. which are for the period from April 1, 2021 through March 31, 2022.
- 3. India Region includes consolidated accounts for three chapters Mumbai, Pune and Bangalore.
- 4. London/U.K. Region WZCC U.K. has been very fortunate as ever since 2001, Dorab Mistry, Lord Bilimoria, and Shernaz Engineer and her team have dug into their own pockets to subsidize or fund their activities.
