## MINUTES OF THE GLOBAL AGM (PERTAINING TO THE YEAR (JANUARY TO DECEMBER 2023) HELD ON JANUARY 5<sup>TH</sup>, 2024 AT 9.30 PM (IST) AT HOTEL CROWN PLAZA, PUNE

Behnaaz Nanavatti being the host introduced the audience by informing them that first time in the history of WZCC, the WZCC flag will be unfurled and handed over by Pune Chapter Chair to Toronto Chapter Chair, where the next Global AGM 2024 is to be held. She requested Captain Master along with Viraf Deboo and Tehmasp Bharucha to accept the flag. This Global AGM was telecasted throughout the world.

Behroze Daruwalla Global Corporate Secretary commenced the AGM. by saying that before She started the meet, by wishing Mr. Aspi Antia, our CEO a very Happy birthday and congratulated him for working with WZCC for such a long time. She also wished our earlier President, Global Emeritus Mr. Minoo Shroff a very Happy Birthday as his birthday was a few days away.

She established the quorum. The Minutes of the Global AGM 2022 held on 15<sup>th</sup> January, 2023 were approved and she informed the Members that it is already put up on our website. Since there was no objection from any Member she requested for proposal and acceptance of the same.

#### Opening Address – Global President.

Capt Percy Master once again wished very Happy Birthday to our CEO Mr. Aspi Antia and Mr. Minoo Shroff who completed 95 years of age. He wished all a Very Happy New Year, prosperity and good health. He mentioned that in the year 2022 WZCC had formed certain initiatives for the growth of our organization and which were implemented in 2023 and now in 2024 WZCC will be in a position and recognized as a Global Brand to be reckoned with. He stated that as a Chamber of Commerce we want to energze and Zarathushti Spirit to make WZCC a better engine for economic and prosperity of our community. Our past was very rich and we must maintain the same for the progress of the future. We want to create a sustainable future for the growth of WZCC members. It can be achieved only by knowledge and wisdom which we learned yesterday by our Dasturji. He stated that anything made by brick and mortar can be destroyed by time but wisdom and knowledge will endure forever.

He elaborated what WZCC had achieved in 2023. A new website has been created and which can be operated not only from the computer but also from the mobile phone. WZCC also completed/issued all the Membership ID cards Globally. All members have been given a unique I D number. Each member has been given a number according to his place of city and he can control the same. The funding to Entrepreneurs has also gained momentum and the response is tremendous. Mr. Philli Kharas heads this Funding Committee and he will speak to you later on about the same. Proud to say we have so far funded 17 Applicants so far and they are doing extremely well today. Few of them have returned the funds. Receiving many applications, as now the word has spread and the community is becoming aware of this project. The main objective of WZCC now, is to raise more funds. This funding facility has also been extended to North America and Canada by way of separate fund called the Zoroastrian Entrepreneur Development Fund (ZEDF). Here also WZCC provides interest free funds to the maximum of USD 50,000.00, so far 5 Applicants have already utilized this facility and are doing extremely well. Besides funding we also give scholarship to deserving students and so far we have funded 2 such students which is given by Zoroastrian Faculty Network is co-ordinated by our immediate past President Mr. Edul Daver. He has raised sufficient funds for the same. Both these funds which are created are helping our community to help them grow.

WZCC has now introduced a Strategic Plan for the year 2022 to 2024 and beyond to enable WZCC to grow. This Strategic Plan will give a momentum to WZCC to grow in the right structured manner. A lot of work behind the scenes have been put into practice. It promotes intellectual, economic and social value, Youth to the fore, Women Empowerment, Chapter Development and Membership, Empower Entrepreneurs, Communication and Outreach. So various members have put in a lot of hard work to accomplish this Strategic Plan and I request all the members to go through this pamphlet.

In order to develop this Global Network system which will benefit our seniors and broaden the horizon and see how business is carried out round the Globe. We have joined hands with various Chambers of Commerce. So far two MOU's have been signed, one recently with the Chamber of Commerce in Goa. One more will be signed shortly and 2 such MOU's are in the pipe line. We are trying with International Chambers of Commerce, where there are more than 200 chambers in their hold and once that happens, then WZCC will have a Global networking which we have never had before. All our members can develop and grow their business accordingly worldwide. The whole idea is that our Chamber of Commerce should grow professionally. The person responsible for this development is none other than our member Mr. Jamshed Mistry, who is instrumental in bringing these Chambers together. Moving with modern times and building the brand of WZCC we are now visible on Social Media, Facebook, Instagram, LinkedIn, YouTube, etc. to promote this brand.

A very good WZCC interview was conducted by Mazda Multimedia for You tube presentation for the India Region along with all the other Zoroastrian Organizations. The interview was widely appreciated by the members of the community and people came to know what WZCC can do and what it is capable of doing. This interview is uploaded on the WZCC Website which is very interesting and one should go through it. WZCC also publishes its Newsletter which will be put on the Website and E Blast. The Newsletter team is headed by Persis Sethna from UK, Dilnavaz Shroff, Zarine Kharas, Shernaz Siganporia and Capt Master. Zarine Kharas is the editor and designer of this product and she does a wonderful job. In order to promote Youth, we have appointed a new Youth Director, Ms. Rashna Jehani to deal with the Youth globally and who has taken over from Jehaan Kotwal whose term as Youth Director has ended. Secondly we also have the 'WE' Wing which is also doing very well globally to encourage Women Entrepreneurs which is headed by Ms. Behroze Daruwalla. The baton which will be passed on to Katayun Kapadia in 2024 and WZCC is sure that it will be taken up to still higher levels to empower Women Entrepreneurs.

Spotlight is another angle which one must not miss about those Entrepreneurs who have come up in life from the bottom of the ladder and who have attained success worldwide and they are also stationed in North America and Canada. They had gone for higher studies and from there

they have reached global heights. It informs us how from a meager sum of money and nothing but hard work has brought them to this level. Spotlight series is a wonderful series and is conducted by none other than Farrokh Mistree and Karishma Koka on a regular basis and the next spotlight is on our caterer Ms. Tanaz Godiwalla which shows how she has developed her business from the scratch.

Developing New Chapters and Regions globally is an ongoing process and we are in the process of adding new chapters in 2024. This project is headed by Viraf Deboo and he is cultivating new Chapters and Regions for us to grow. WZCC is a Global Chamber of Commerce and we have to have our presence Globally.

WZCC has a self-sustained Central Administrative Office in Mumbai and which is possible by contributions from different Chapters and way of advertisements and fund raising drive. Aspi Antia is our CEO who is doing a wonderful job for our Administrative Office.

In order to have increased participation from our Iranian Youths in the Zoroastrian Community, we have recently introduced WZCC Iranian Youth Network and which is mentored by Farrokh Mistree, Edul Daver and Karishma Koka because we would like them to come up in life as they have suffered a lot and it is our duty to bring them up as our roots are in Iran. They require our help in every possible manner. Our CAO is doing dedicated work, maintaining Statutory Commissions of the Charity Commissioner, taxation and various other compliance.

Capt Master also congratulated the Pune Chapter for hosting the Pune Conclave which is run by Viraf Deboo, Tehmasp Bharucha and his team. It was nothing but team effort and we must encourage this talent. "We cannot build the future for the youth but definitely we can build the youth for the future". This is the message of WZCC for the youth which we must incorporate. His message for the youth is to have a very strong will power, speak the truth, it is difficult to make a name but more difficult to retain it. Develop the courage to act as per your convictions and do what is right. A little advice to all parents and grand-parents who are present here today that we require your support to encourage our children and grand- children and always follow the path of truth which is the principle of our religion and which has stood the test of the time since last thousand years. We may be small in number but we are a blessed community. Ahura Mazda is guiding us but we must be united. Each parent and grandparent must take upon themselves that their children take interest in our religion, wear our "sadra and kushti". Since we have given too much freedom to our children, we are suffering today. Our community is falling down which is solely due to us as we are not following our religion today. He also mentioned that when we were kids and before going to school, we were made to visit our Fire temple. Now in this modern times, it is not possible today but at least say our basic morning prayers before leaving for school and office. As long as Zarathushtra guides us on the path of truth, there is no looking back and you will succeed.

Prof Farrokh Mistree informed the audience that 5 members of the Iranian Zoroastrian Youth Network have come to the Conclave and he introduced them to the Members. Their main purpose is that they would like to develop the Yazd Cultural Heritage Resort and are in dire need of funds to achieve the purpose and for that we need your help and co-operation.

#### Message from Global Vice-President.

Global President, Capt. Percy Master to read out the message of Vice President Perses Sethna from UK since he is not available. He mentioned that the Newsletter team is doing an excellent job and it is not easy for them to compile everything, do the editing and then give it for publishing on time which is indeed commendable, he congratulated them for the same.

The team is headed by Perses Sethna, Zarine Kharas from Australia and even though we are all spread round the world, but it is because of zoom meetings which is done every 15 days that we are able to do it on time as we have to collect from different sources from well-known Zoroastrians from round the world and wished them success by adding that they are doing a super duper job. So Capt Master thanked them once again and hope that it continues for a long time.

The Global Secretary's Report.

Behroze Daruwalla introduced herself and informed the audience that it gave her great pleasure to inform them about the WZCC Report from January 2023 to Dec 2023. In all we have 14 Chapters and 4 Area Representative Offices (AROs) as well as Global committees. Our committees are appointed as and when required. Our 15 Committees comprises Global Committee, Social Media Committee, Youth Committee, Newsletter Committee, Entrepreneur Committee, Start up and Business Advisory Committee, Quarterly Newsletter Committee, Fund Raising and Finance Committee, Membership Committee, Zoroastrian Education Network, I D cards Committee whereby each and every member gets an I D card with a unique number and has to be carried all the time so that he can enjoy the facilities of WZCC at discounted rates, Spotlight, Woman Entrepreneurs and Global awards, Compliance Committee, Legal Committee. These last 2 committees have just come up last year as we have to deal with government agencies, so the compliance committee has been formed so that we do not fall in their trap since we are all volunteers doing social work. The Legal committee has also been formed so that our young recently graduated lawyers know what is happening and they are in the loop. 'WE' Wing, as you are all aware have their regular zoom meetings so that we have Global participation. Our Conclaves and AGM's are held every year in different parts of the world and weather conditions which has to be taken into account. They are both held separately and the time gap has to be taken into consideration for future Conclaves and AGM as the last Conclave was held in London just 6 months back and now we are having our Pune Conclave barely 6 months away. The Awards are conferred at the Conclaves and now since we are all having physical meeting, we will have to widen our time frame between 2 Conclaves. The Membership Committee is headed by Viraf Deboo and we are trying to bring in more and more new members globally. We were inactive for some time because of covid and now since we are active, we are trying our best to add 2 more Chapters in our wing who have become inactive and are trying to revive New Delhi and Ahmedabad Chapters. Our new website has been recently revamped and we are trying to make it as simple as possible so that we reach out to the world even those who are not members as we are just 1000 members which is not a good sign so we need new members to come forward as we are global and we have to spread the awareness as outsiders are unaware of WZCC. Recently we have signed up with Goa Chamber of Commerce and shortly we will be signing in Pune with Asian Chamber of Commerce and there are few which are in the pipe line and Jamshed Mistry will be heading this new Committee. Now we have various committees and that person will be responsible for the same. All information which is received by the CAO is put up on the website, E Blasts are going out in full swing and we request all our Chapter Chairs to send us as much information immediately before or after the function is over so that there are more hits on the website and people get to know about it asap. All chapters are having their own physical meeting, Meet and Greet in order to have active participation. By Zoom meeting we have Global participation so that it reaches out to everybody round the world. Our CAO at Tardeo, which is headed by Aspi Antia is doing excellent work and that she visits the office once a week to assist them as and when the need arises and she wished all the Chapters the very best.

#### Global Treasurer Report.

Ratan Mistry mentioned that the Financial Statements are in USD, the balance in USD is about three hundred and fifty-six thousand dollars. This is increase over two hundred and seventy thousand dollars from the previous year. The profit for WZCC for 2022 - 23 is seventy-three thousand US Dollars. He requested all the Chapters Chairs to send their dues.

"WE" Wing Report.

Behroze mentioned that Mr.Minoo Shroff in 2012 requested that WZCC should have a Ladies Wing and it was started in Mumbai by a group of ladies and in 2015 it went Global and started WE Wing, Women Empowerment and it was well received and requested all Chapter Chairs to have atleast either one or two ladies on the committee so that we have women oriented

programs. It started off on a very small scale and many men wanted to pitch in and wanted to attend the programs as well. So we had many programs which were only for women and certain which both the genders could attend and how to turn your hobby into a profession. We have programs once in two months and all the meetings are held in zoom because of covid. We showed ladies who have broken the ceiling and ladies who have come forward with their talent and skills, ladies who are with NGO's, had varied programs and show cased their talent. In March we have an International Ladies Program and encourage them to come forward. During covid, many ladies lost their jobs and she suggested that those who are expert in Bakery, making food, etc. to come forward and start doing their work thereby making them independent. Started our whatsapp group, caught hold of delivery boys. She proudly mentioned that out of five such entrepreneurs three women were called back by their respective countries, but refused to go back and now are doing extremely well in sending food on a daily basis. They further mentioned that their mother in laws refused to send them back to work because they earned well and they looked after them as well children in the house. She concluded by saying that WE ladies group is doing very well and they are in regular touch with each other on Zoom round the world on a regular basis. Programs are arranged, negotiations are done, speakers are finalized and E-blast are then sent regular to all the members by CAO. She proudly mentioned that now since 'WE' wing is well established and she can proudly hand over the baton to Katayun Kapadia when term is getting over in December and who will run the show for a further period of 3 years and that she has got a wonderful team of ladies to help her in the activities of WE Wing.

Business Advisory Committee (BAC) Report.

Mr Phili Kharas wished all a very Happy New Year. He informed the audience that the BAC which has eleven Committee Members, is doing excellent work since 2019 and as of today funded and mentored 17 applicants having started with a Corpus of one crore and sixty-five lakhs and the entire corpus has been used and the balance as of today from the repayments we have received is Rupees forty-five lakhs. When we receive the applicants, our maximum funding is twenty-five lakhs. We cannot fund more than 2 such applicants. So we have to get more funds from HNIs of our community. Entrepreneurs create jobs, and to promote entrepreneurship it is not an easy job. He gave an example of Cyrus Mistry, one of the Fund Applicants who is rather doing very well and is here today to show case his wares.

Behroze Daruwalla informed the audience that all the reports are kept on our new website and anybody can have a look or access to it.

#### Youth Wing Report:

Youth Director, Rashna Jehani, thanked everyone for supporting her in her new endeavor as the last Youth Director term got over and now she has stepped in the shoes of Jehan Kotwal whose term has expired. She wanted to bring a lot of new ideas for which she requested the support of all the members.

#### Award Winners 2023:

Behroze informed the audience the names of the WZCC Outstanding Award Winners. They are

- Cyrus Rivetna for Outstanding Zarathushti Entrepeneur of the year 2023
- Tehmasp Printer for Outstanding Zarathushti Professional of the year 2023
- Rashneh Pardiwala for Outstanding Zarathushti Social Entrepreneur of the year 2023
- Jehan Daruvala for Outstanding Young Zarathushti Professional of the year 2023
- Berjeesh D Surty, was given A Citation of Honour, the pioneering Zarathushti Entrepreneur who shaped and influenced the lives in East Africa.
- Citation of Honour Mr. Berjeesh Surty.

Capt Master announced the Citation of Honour to Mr. Berjeesh Surty so a Citation of Honour will be presented during the Awards night. Mr. Surty is a pioneering Zarathushti entrepreneur who changed the lives in East Africa. His specialty is in Solar energy, Industrial Boilers, waste water management and agriculture. He has started on his own and a very enterprising personality which is thriving in East Africa. He has specially come all the way from East Africa all the way to accept the Award.

#### Honorary Member 2023.

Capt Master announced the name of Mr. Berjis Desai as WZCC Honorary Member 2023. He informed the audience about the activities of Mr. Desai, his qualifications, experience, etc to the audience. He has assured that he will help us in achieving our target and he was not even aware as regards the activities of WZCC and we are proud to have him on our board as Honorary Member of WZCC.

Zerick Dastur introduced Mr. Berjis Desai to the audience. He informed the audience that Berjis Desai was a giver and not a taker in the true sense of the word. He has nurtured hundreds of students in their respective legal field when he was the MD of J. Sagar & Associates, he makes careers of students in the legal fraternity. He helps individuals to set up their own law firms and make them stand on their own feet. As far as our community is concerned, he does a lot of charity work, philanthropic activities, for e.g. Mumbai Metro case where the digging was in the way of our ancestral Atash Behram in Mumbai Dhobi Talao, he fought tooth and nail and agreed to become a Petitioners and volunteered in this case. He stood up financially and even contributed from his pocket, that shows us the nature of this person for the benefit of the community. He welcomed Mr. Berjis Desai to become a part of this forum. Since he was not available for the Pune Conclave he has sent WZCC his greetings and was grateful to WZCC for bestowing him the honor of Honorary Member.

Mr. Berjis Desai in his video speech admired the initiatives of WZCC, avoiding skepticism, encourage entrepreneurship in the present state of the community. When the Parsees came to India 1300 years ago as refugees, it was an overwhelming probability that we would get lost but Parsees overcame the challenges in the great Indian melting pot. We not only survived but also thrived. It was due solely to the vision of our forefathers, who graduated from farmers to traders, ship builders, etc of modern India. We often forget one important factor in success which is the risk taking factor which is missing in our community. All great Parsee house, like The Tatas, House of Godrej, the Wadias, Shapoorji Pallonji and Dr. Cyrus Poonawalla whose business are still thriving in the present world which is 60 years old and other Engineering businesses Houses like Thermax, Forbes and Marshall but in the last 50 years there has not been a single Parsi Business House. Professional success is there on a very large scale but there is no risk taking credit ability to create. It is time that WZCC expands its creativity and gets a corpus of Rs.100 crores for a period of 2 years. Where there are ideas and capability, capital will follow. This will give a sense of idea and pride to our community. He thanked the ideas of WZCC and requested members to contribute on a large scale.

Behroze informed the audience that the next Conclave will be held in Toronto in April 2025 and showed a small video presentation of the Toronto city.

#### New Directors:

Behroze announced the Nominations of New Directors from January 2024 to be ratified as the terms of many of them are getting over. They have either completed their terms or do not want to continue further for personal reasons. Jehaan Kotwal has completed his term as Youth Director and will be replaced by Rashna Jehani, Zarine Kharas who has resigned with effect from December 2023 will be replaced by Jimmy Medhora, Pervin Talyerkhan will be replaced by Ketayun Kapadia as Director, USA and also Afsaan Kermani has resigned from December 2023. New Directors who will be joining from January 2024 are Ketayun Kapadia, Jimmy Medhora, Rashna Jehani and Cyrus Patel.

Edul Davar wanted a change in the Constitution and get it ratified by March 2024. He wants Capt Master to continue for his third term, so he wanted the feedback from all present at the Conclave.

Capt Master further informed that the Conclave should not be held every year as it is not possible for all to attend and it should be held every two years so that it is cost effective and as well as time consuming for all, failing which the attendance will be not appropriate as everybody cannot afford the same. He asked the feedback from the audience and it was seconded by Arzan Wadia along with Behram Pastakia who seconded the same that it is really good suggestion. AGM will be held every year by zoom or physical in January.

Mr. Kharas informed the audience that in order to raise funds for BAC, he suggested Madison World of Sam Balsara to prepare an advertisement in two Parsee newspapers as to why WZCC needs additional funds and the cost will be borne by all BAC members which will give a lot of information to the general public as what we are doing to our funds.

Rohinton Rivetna informed that there were two excellent stalwart members Mr. Homi Davier who was a travel agent and Sarosh Collector who was the WZCC treasurer who passed away in Houston and it should be mentioned on the WZCC website about the yeoman services they have given us. Behroze further added that she knew both of them personally and they were founding members as she has worked with Homi Davier who was a travel agent and who was the brain behind hosting the Conclave in Las Vegas in 2019.

Piloo Aga mentioned that not to keep the Conclave after every 2 years but it should be held every year failing which the touch will be lost and the flame will not be kept burning. Even if there are 100 members who are present, it is more than enough and she was the first one to register for the Pune Conclave as mentioned by Viraf Deboo. Prof Farrokh Mistree informed the audience about the 5 guests who have come all the way from Iran and were interested in Opening Zorastrian Restaurtants, Museums, etc. in historical places of interest in Yazd and that we should encourage them in their endeavor.

Behroze requested Mr. Adi Siganporia to close the meet.

Mr Siganporia thanked each and every Chapter Chair, Directors, CEO Aspi Antia the very best and the Pune Conclave personnel Tehmasp Bharucha and Viraf Deboo for doing an excellent job for the Pune Conclave.

The Meeting ended with a vote of thanks to the Chair.



#### **GLOBAL PRESIDENT'S REPORT – 2024**

It gives me great pleasure in submitting the annual report as a Global President of WZCC for the year gone by.

We have continued the progress that we started few years back.

In order to sustain all-inclusive progress, we decided to implement a strategic plan in the year 2022. The main thrust areas of this strategic plan was to identify seven thrust areas where WZCC should concentrate in the years to come.

- 1. To promote intellectual, economic and social values.
- 2. Youth to the fore.
- 3. Women Empowerment
- 4. Chapter development and membership
- 5. Empowering entrepreneurs and professional
- 6. Community and outreach
- 7. Networking

We recognized that in order for our community to succeed we needed to educate our youth to the highest level possible. So the first area of concentration was Thrust 1 – to promote intellectual economic and social values. This is the Eco system on which the progress will be made by WZCC, in the future.

We all know that education is the key to success in life. Intellectual growth should commence at birth and cease only on death. In fact education is the passport to future for tomorrow belongs to those who prepare for it today. In this regard we are promoting education so that our community can look to our future with confidence. Good education will lead our youth to become good professional and entrepreneurs. Once they succeed we are sure they will develop the philanthropic spirit of Zarathushti, which is well known.

The second part of our thrust area is to promote youth as much as we can. Our slogan since year 2022, has been "Power of Youth driving future generation". Youth are the future of our very existence and we would be failing in our duty if we do not promote youth to succeed. Our numbers are dwindling fast.

as we are an aging community and have very miniscule younger population. As per the census held in 2011, we were about 61000 in India. I am almost certain that the current figure will be well below 50000, we exist mainly in Gujarat and Maharashtra states of India. Mumbai/Bombay being the largest contingent of Zarathushti. We must remember that our roots are in India and this is our motherland. Our forefathers created reputable business houses, hospitals, education institutions, residential colonies and several trusts to look after the wellbeing of our community. If we do not preserve these facilities in India we will not be able to maintain our 8 Atash Behrams and over 100 odd fire temples which they have so diligently built. In fact, the Iranshah fire is situated in Udwada in India.

We must therefore create facilities which will encourage our youth to remain in India, consolidate and prosper. This can be done if we have the will to do so. The Government of India has restarted the Jio Parsi scheme but more needs to be done by us for the community to multiply rapidly.

In order to promote youth we have created various facilities, the one game changer is providing startup finance to young entrepreneurs and professionals. We have financed 18 such start-ups, who have been successful and more are in the pipeline. We are providing Rs. Twenty-five Lakhs interest free finance for a period of 3 years, plus 6 months as moratorium. The corpus created for this funding is on a rotational basis. Several of the recipients have returned the money before time to enable us to give finance to other startups. A similar fund is now being created in North America in **FEZANA** ZEDF, Zarathushti collaboration with known as Entrepreneurship Development Foundation. This facility gives USD 50000 interest free with similar conditions. We have financed 5-6 startups which are also doing well. Due to the excess funds available with ZEDF, education scholarships are also being given up to USD 15000. This initiative according to me is a game changer for the progress of our youth.

Another initiative which WZCC has taken is to develop extensive outside our community by engaging with multiple chambers of commerce worldwide. WZCC, has become member of the ICC, International Chamber of Commerce, where we have 245 chambers with 1.45 million members, a networking beyond compare.

According to me you can promote your business worldwide. In order to encourage and give experience to our youth we have a monthly spotlight which we conduct WZCC-ZEN – Zoroastrian Education Fund, under Farrokh Mistree and Karishma Koka, where successful entrepreneurs and professionals are interviewed and moderated to give their experience and their successes stories.

This spotlight gives a lot of knowledge to our youngsters and it is a great learning experience for seniors as well. Besides this we conduct several webinars on different topics. We have also created a Youth Network by selecting a Youth from each of the 14 chapters and formed a group which will concentrate on the development of youth in their jurisdiction.

Further we have tied up with FEZANA's youth and social media platforms to create a synergy between our youngsters. We are in the process of developing a Youth

Network by collaborating with various youth organizations to make a combined effort to promote youth by having webinars of several successful youths so that these successful events can be held by the youth, for the youth. We are sure this global youth network will promote friendship, exchange of ideas, learning experiences and above all good fellowship for the future generation to interact and marry within the community. We also have a quarterly newsletter which promotes activities of WZCC globally. Some outstanding articles on Finance and other topics are also included. This newsletter is widely circulated on social media and other apps. WZCC has created these facilities for our youth and I recommend that youth take advantage of these facilities. You can login to our website – wzcc.org which can also be operated also on your mobile phones.

We have several schemes; the budding youth program gives free membership between the ages of 15-18 years. You have to just fill a form available on the website. We have student membership between age group 18-21 years as well.

To potential entrepreneurs – I say, Entrepreneurship is living a few years of your life like most people want, so that you can spend the rest of your life like most people can't.

To professionals – I say, Professional is not a label you give yourself. It's a description, you hope others will apply to you.

The good human relations not only bring great personal rewards but are essential to the success of any enterprise.

Through workshops, seminars, webinars and collaborative ventures, we have equipped our members with the skills and insights needed to navigate and excel in the ever evolving business landscape.

Three years ago we started the social and media initiatives which are picking up very well -thanks to Capt. Percy Master; our dynamic Global President and members of various global regions, including India..... We now have a well-designed and vibrant newsletter and website.

India region has three active chapters and we are still trying to expand to other Chapters like Hyderabad, Delhi and Ahmedabad. We are in talks with candidates who are showing interest in igniting and starting new chapters in these cities and hope to visit these cities soon.

Each Chapter and sub-committee has provided a brief outline of their activities in this report. However here are some general observations that I want to place before you as President of India Region up to September 2024. The baton of presidency of India Region has now been handed over to a very capable next gen member Mr. Zerick Dastur.

We have started being proactive with youngsters, as young as 12-18 years old and we do not charge any fees...they just have to fill out a form and provide us with contact details and they will get all the information to participate in all our programs.

From 18 to 21 we charge only Rs.1000/- and after 21 years that youth can decide whether he/she wants to become a life member or remain an annual member.

WZCC India Region has become very active on Social Media since Youth seem to rely on these day and last year our website was revamped completely.

WZCC has launched newsletter and webinars on spotlight both are doing a brilliant job of uplifting the image of WZCC to the next level.

Another focus has been to enhance a "Business Advisory Committee". Members of this committee promote and mentor WZCC members by providing start-up funding up to Rs.25 lakhs which are interest free. The seniors also assist and guide them with their business plans and balance sheet. Our seasoned committee members ask them strategic questions which makes them think differently and strategically. So far we have funded 19 applicants who are being mentored by BAC committee and are doing very well.

We have provided these funds to entrepreneurs and professionals in various fields and industries including manufacturing units, laser dyes, lab grown diamonds, shipping containers, accounting, pizza outlets, cloud kitchen, custom furniture, hydroponic farming, hospitality industry etc. I am happy to report that all our candidates are doing well and prospering.

For years WZCC has been conducting and encouraging the youth. WZCC India regularly takes part in the holiday program for the youth organised by Bombay Parsi Panchayat in Mumbai along with other programs in other cities. WZCC spends a whole day holding talks and competition with the youth and is available to any organisation who requests that WZCC provide information on professions and entrepreneurship. WZCC India always tries to improve and evolve. Our two committees — WZCC Legal Committee and WZCC Compliance Committees are doing very well. Issues related to government entities like Charity Commission's office and Income Tax are being handled efficiently and on time.

WZCC Legal Committee comprises of eminent lawyers from our community who provide information and hold informative functions. They are doing yeomen services to the community legal fraternity.

#### ANNUAL REPORT-BANGALORE CHAPTER -2023-2024



Rashna Writer is a political scientist. She commenced her career as a Research Associate at the International Institute for Strategic Studies, London; went on to become a Contributing Editor of the Defense & Foreign Affairs Handbook; Defense & Foreign Affairs Strategic Policy. Subsequently, she was Head of Global Risks for a strategic risk consultancy in the UK, where she specialized in advising Lloyds of London syndicates specialty insurance underwriters on war, political and terrorism risks. She was a senior advisor to some European companies. She occasionally contributed on CNBC, Bloomberg and Reuters television on strategic risk issues.

Rashna pursued a parallel career in academia. She is the author of Contemporary Zoroastrians: An Unstructured Nation (1994); co-author, with Shahrokh Shahrokh of The Memoirs of Keikhosrow Shahrokh (1994), and author of The Reshaping of Iran from Zoroastrian to Muslim (2013), and the audio book The Story of the Zoroastrians: An Historical Perspective (2021). She has lectured on ancient Iranian history at Birbeck College (London) and Richmond College (London); was a Research Assistant at Manchester University where she undertook work on the Zoroastrian community in the United Kingdom. Between 2008 and 2019, she was Senior Teaching Fellow in the Department of Study of Religions, School of Oriental and African Studies (SOAS), London University, where she lectured on Zoroastrianism in Ancient and Modern Worlds. She has participated at international conferences and lectured in the UK, USA and the Indian sub-continent on Iranian history. Among her awards were a Commonwealth Scholarship (1973), and a Fellowship of the British Institute of Persian Studies (1988/89). She was a member of the National Employment Panel: 2006-2007, commissioned by Britain's then Chancellor of the Exchequer, Gordon Brown, before his elevation to the office of Prime Minister. Rashna Writer holds a doctorate from the London School of Economics in International Relations.

### Annual Report - Houston Chapter 2024

The WZCC – Houston Chapter had another successful year in which we held three successful events, plus a fourth all-day event that will be held prior to the start of the North American Zoroastrian Congress at the end of the year. The distinguished speakers for the three seminars were carefully chosen for their expertise in various topics that help our members in their professional, business, or personal lives. Each event was well attended and we received positive feedback from our members about the value provided by the seminars. A summary of the events held in 2024 is as follows:

IRAs and 401(k)s – Strategies and Opportunities for 2024, by Farokh Billimoria Farokh Billimoria has 40 years of experience in retirement planning and personal finance, and he provided valuable strategies for growing wealth. He discussed benefits of Roth IRAs, the pitfalls to avoid when inheriting IRAs, donating funds from IRAs to qualified charities, strategies related to taking the required minimum distributions from your retirement accounts, and watch points for traditional IRAs and 401(k)s. This seminar was heavily attended and was followed by a robust Q&A session.

## "Practical Applications of Today's Artificial Intelligence in Business", by Farzad Sunavala

A highly informative session on Artificial Intelligence (AI) tools in Business" was presented by Farzad Sunavala. Farzad is a Senior Product Manager at Microsoft, where he has an instrumental role in leading the product design and execution of Search and AI capabilities in Microsoft Azure. Farzad presented how AI will impact all business fields and our everyday personal lives, and he was passionate about empowering individuals and organizations in creating cutting-edge experiences that revolutionize the way we interact with technology. He shared how studies are indicating that a return of \$3.50 is realized by companies for every \$1 that they invest in AI. He also demonstrated how AI technology usage is growing at an extremely fast pace. For instance, it took the internet 7 years to reach 100 million users, whereas it took 3 months for the AI application ChatGPT to be utilized by 100 million users. Farzad also discussed the negative aspects of AI and the need for caution. The participants of this meeting greatly enjoyed the learnings from this enlightening session.

### "The Avestagenome Project", by Dr. Villoo Morawala Patell

Dr. Villoo Patel, the Founder & Chairperson of Avesthagen Ltd & AGENOME LLC, USA conducted an insightful session on genetic testing being conducted by her organization. Dr. Patell is an innovator and entrepreneur involved in international biotechnology development, and academic and corporate leadership resulting in global networks and alliances. She is also the recipient of many national and international awards including the French National Order "L'officier du Merit" and the "Karmaveer

### Puraskar" Award.

Avesthagen Ltd. is a life science company, strategically positioned at the convergence of food, pharma, and population genetics. The company's flagship initiative, The Avestagenome Project, delves into the molecular underpinnings of longevity and disease prevalence within communities, particularly focusing on the Zoroastrian population. The project aims to decipher the genetic basis of increased disease susceptibility such as Cancers, Parkinson's, Alzheimer's etc. and it possesses a unique biobank of 4,700 Zoroastrians with a goal to increase this to 10,000. The vast databank would enable predictive diagnostics, and preventive and precision therapies.

### WZCC-Houston Pre-Congress Day Trip

### **ANNUAL REPORT - YOUTH WING - 2024**

### Introduction

In the words of Monica Ande "The youth are the architects of tomorrow's world."

The World Zoroastrian Chamber of Commerce (WZCC) firmly believes in the power of youth to shape the future. Our mission is to empower and engage Zoroastrian youth globally, providing them with opportunities to grow, learn, and connect with each other. Through our diverse initiatives and programs, we aim to foster a vibrant and successful community that celebrates the achievements of our young members.

In our mission to empower Zarathushti youth globally, nine regions, each with a dedicated Youth Director, take charge as local leaders. From North America to Asia, these Youth Directors actively engage with their chapters, addressing unique regional needs. Through a dynamic WhatsApp network, these leaders exchange updates, insights, and strategies, fostering global connectivity. This collaborative platform allows them to adapt successful event approaches, share emerging trends, and collectively contribute to the WZCC Youth Wing's mission. This decentralized leadership model ensures targeted regional initiatives while keeping the global Zarathushti youth community interconnected and mutually supportive.

The below are the highlights of key events held between January 2024 – December 2024:

### 1. Holiday Program for Youth (Mumbai):

Successfully organised the HPY event catered specifically to 10th graders attended by over 100 youngsters, fostering innovation, instilling a spirit of resilience, and providing a platform for young minds to envision and pursue their entrepreneurial dreams. the program unfolded in collaboration with the Mumbai Chapter, creating a rich learning environment.

The event was executed by Behnaaz Nanavatti, WZCC youth director India along with a dynamic set of volunteers. The day-long event combined interactive workshops, engaging activities, and insightful discussions, ensuring that each attendee not only grasped theoretical concepts but also had a hands-on experience.

### 2. WZCC x FOZYA Youth Conclave:

Topic: My Inspiring Journey As An Entrepreneur by Yassmin Mistry

Every year, WZCC-WE celebrates International Women's Day with a global webinar and so today, we had Yassmin Mistry to take us on her Inspiring Journey as an Entrepreneur. Behroze Daruwalla, gave a brief insight on the activities of the WZCC-WE wing and then Katayun introduced the speaker.

Yassmin took us on an inspiring journey with her as to how at the young age of 19, on the sudden passing away of her father - Jal Mistry, a much-loved and cherished industrialist a force to reckon with in the Zoroastrian community, the onus of managing her father's business fell on her young shoulders. As head of the business, she quickly learned the intricacies of managing the business and emerged victorious by expanding the Transport organization into a Logistics Giant proving her mettle as a bold, worthy and strong entrepreneur in an industry dominated by men. She thanked Godrej

enterprise for giving her, her first chance. Yassmin said that grit and persistence helped her to turn her inheritance into a legacy. Dorab Mistry told Yassmin about remembering her father and his trucking business association with Godrej.

Yassmin also runs a community based NGO since 2009 and is the founder Trustee of Zoroastrian Trust Funds of India (ZTFI). Yassmin spoke passionately about ZTFI and her sense of duty to give back to her Parsi/Irani Zoroastrian community. Yassmin demonstrated her leadership skills by taking these organizations from strength to strength. Her ability to navigate various sectors showcased her as a versatile and astute businesswoman. For her, failure was not an option and she always wanted to be first. Yassmin Mistry's journey of three decades was marked by resilience, compassion and an unwavering commitment to excellence. She stands as a role model for aspiring entrepreneurs, showcasing that success is not just about achieving personal milestones but also about making a positive impact on the community and society at large.

In the Q&A session, moderated by Arin Master and Behroze Daruwalla, Yassmin spoke about the tough decisions she had to make and the ethical choices she made to achieve the successes as a woman in a man's world, but she said she was a very persistent person, she put her foot down and she achieved her objectives. She said she was not a person who gave up easily. Yassmin was asked how to rope in the youngsters and get them interested in being entrepreneurs. Yassmin said that the young people today are very knowledgeable, they are very clear in what they want. Be open, learn from your past, your achievements, victories and failures. Inspiration is what you need. It is always about us and not me.

WZCC President Percy Master first spoke enthusiastically on the treasured place of women, WZCC-WE Global Chair Katayun Kapadia gave a Welcome Message and Thanks, WZCC-NY Member Zareen Mistry introduced Nawaz, and Natalie Gandhi, WZCC-NY Chair, conducted a Q&A discussion.

Nawaz shared her journey from writing as a hobby to becoming a full-time author (now delivering on her fourth book) after a successful corporate career. She emphasized the importance of empathy in her detective novels, reflecting her experiences as an

Here are some of the gleanings from the webinar:

- Live your life by design-- not by default.
- The first million is the hardest-- the rest is inevitable.
- Financial freedom means different things to different people.
- Create M.A.P system; Mind set / Action it/ Plan it; others have achieved it-- so can you!
- Let the business work for you--you don't be the business!
- Scale your business and become bigger! 7. If I can do it-- so can you!

An interactive question hour followed where participants put forth their problems relating to marketing/social media and even "Can I start my business at the age of 73?" asked one participant. Firuzi interacted with all, with fun and learning . She even offered to mentor the first 10 participants with their businesses! This was a truly global webinar. #### **GLOBAL WEBINAR #4**

Topic: Navigating Entrepreneurship: A Journey with Navaz Sethna from

#### **Volkwagen Group To Kumon**

This WZCC-WE webinar On October 5, 2024 was a delightful blend of entrepreneurial wisdom, life lessons, and the kind of storytelling that makes you wonder if the business world isn't just one big sitcom waiting to happen. Led by the ever-charming Navaz Sethna, from WZCC-UK, the session offered an insightful (and often humorous) dive into her journey from a wide-eyed student to a seasoned entrepreneur.

Starting at 18 and Knowing Nothing (Relatable, Right?): Navaz began with a confession that could resonate with many of us: she started her entrepreneurial journey at 18 with no idea what she was doing. Enrolled in a European Business degree, Navaz split her time between the UK and Germany—an adventurous mix of cultures, languages, and the unexpected realization that she probably should have read the course prospectus more carefully. Her takeaway? "It's okay to not have everything figured out at 18. Just pack some enthusiasm, a sense of humour, and maybe a good map for navigating German trains."

From Corporate Cubicles to Creative Freedom: After graduating, Navaz entered the corporate world—because what else does one do when faced with a mountain of student debt? It was here she honed her skills, learning how to lead, manage, and (occasionally) survive meetings that felt longer than the European Union's budget negotiations. But corporate life wasn't all spreadsheets and staplers. It gave Navaz a taste for solving problems, building teams, and spotting opportunities. Eventually, this led her to venture out on her own, trading the safety net of corporate cubicles for the thrilling rollercoaster of entrepreneurship.

Entrepreneurship: Glamorous Chaos: Navaz described starting her first business as equal parts exhilarating and chaotic. From navigating the joys of finding clients to the sheer terror of tax season, her anecdotes had everyone nodding in sympathy (and possibly pouring an extra glass of wine). Her advice? "Entrepreneurship isn't about avoiding failure; it's about laughing through it and moving forward."

Community and Collaboration: The Secret Sauce: Navaz emphasized the importance of surrounding yourself with a supportive community. It starts with a supportive partner (in this case her life and business partner Professor (Dr) Zubin Sethna), through to family, friends, and/or fellow entrepreneurs; having a circle that cheers you on. From partnering with other businesses to learning from mentors, Navaz stressed that no entrepreneur is an island. "Unless, of course," she joked, "you're running a tropical retreat business—then maybe you are an island."

#### Advice for Aspiring Entrepreneurs:

Navaz shared some golden nuggets of advice for anyone dreaming of starting their own business:

- Find Your Why: Passion is great, but a clear purpose will keep you going when the going gets tough (and it will).
- Start Small, Dream Big: You don't need a fancy office or a perfect plan to start. Begin where you are, with what you have.
- Learn Continuously: Whether it's from books, mentors, or mistakes, every experience is a chance to grow.

 Have Fun: "If you're not having fun," Navaz quipped, "you might as well go back to those long corporate meetings."

The webinar ended with a lively Q&A session, covering everything from balancing work and life to managing self-doubt. Navaz answered with her trademark wit and warmth, leaving attendees inspired and a little less scared of diving into the world of entrepreneurship. Shernaz Engineer introduced us to Navaz and Dorab Mistry gave the vote of thanks.

If there's one thing we took away from this session, it's that entrepreneurship isn't just about building a business—it's about building a life you love. Navaz's journey reminded us that success comes with a mix of hard work, resilience, and the ability to laugh at yourself when things go awry.

#### **GLOBAL WEBINAR #5**

#### **Topic: Empowering Yourself At The Workplace**

"Welcome to the fifth and final webinar of the year 2024" said Katayun Kapadia, the global chair of WE, as she welcomed the participants from all over the globe:on December 1, 2024, to an interactive webinar on "Empowering yourself at the workplace" by Adv Sana Hakim.

Sexual Harassment is a critically concerned subject globally. said Captain Percy Master, Global President of WZCC, in his opening remarks ."Our religion believes in gender equality" as he referred to the gender equality prevalent and enforced in the reign of Emperor Cyrus -- where women had equal rights in business/politics and all walks of life. Thus, giving more power to women.

Empowering women in the workplace is a winning strategy for both the women and the business. With the advent of various kinds of instances at workplaces globally, there is a rising awareness of rights of employees and obligations of employers across sectors.

Workplaces are not immune to instances of violations. One of the most reported forms is sexual harassment at the workplace, said Farida Deboo of the WZCC Pune Chapter, as she introduced the speaker, Adv Sana Hakim; a subject matter expert practicing in the space of diversity and inclusion, family and criminal laws for more than 15 years now. Adv Sana Hakim is a co-founding partner of Equilibrio Advisory, which is a firm of lawyers and psychologists. Setting the context at the outset, Sana laid down the ground rules for sharing experiences; while hoping to create a safe place for everybody to have an open conversation.

Is sexual harassment industry specific? Is there a correlation between the industry setup? Which industry had the highest case reported? Did you know that one in every 5 women and one in every 5 men have faced sexual harassment-----United Nations. In the film industry, 90% respondents said that they had experienced sexual harassment. However, a large number had not reported their cases. And most of them were women! In the Indian context, a study showed that among Sensex firms, 83% of sexual harassment caseswere reported from the IT and Banking sectors. which showed that the population here had recourse to reporting and were aware of the problem. It was the question of reporting and recourse to reporting the problem. Why do people not report it? Is it embarrassment/will I be labelled as a trouble- maker?

As Sana moved from the macro to the individual, citing boundaries of time and emotion relationships-- which are very individually specific and not gender specific, we realized that many people find it difficult to assert themselves, and very often Sexual Harassment emanates from a position of privilege and power. Sana explained to us what constitutes sexual harassment as per POSH Act 2013.

Sana shared examples of cases where one crosses professional boundaries and makes remarks which are intrusive and uncomfortable, asks inappropriate questions and makes suggestions. However, in sexual harassment cases, the Impact supersedes the Intent; it can have a significant impact on a person's psychological, physical and professional wellbeing. Causes of sexual harassment: Power dynamics and position; imbalance /gender inequality; Patriarchy, men's perceived role in society; no recourse for redressal.

Can we prevent Sexual harassment at the workplace? "Yes", said Sana "I am a diehard optimist and believe that it can and is being done." Sensitizing and educating employees to the problem and the forms of sexual harassment; legal recourses; strong focus on the legal compliances; in India the POSH act of 2013 was passed to make workplaces safer for women. One of the participants shared that there were more cases reported in organizations where the Posh Committee was set up. Thus, a legal recourse in an organisation, empowers women to stand up for their rights highlighting the employee's role; not to be bystanders.

The session ended with a crisp and concise vote of thanks by Yasmin Medhora, appreciating Adv Sana Hakim for educating and sensitizing the group on the understanding the scope of meaning of sexual harassment, the rights andobligations of individuals and legal recourses.

It was in an interactive and participative session, with case studies and real-life experiences. It truly impacted us all. As WE members let us not be bystanders; let us unite to empower women at the workplaces and beyond

#### ANNUAL REPORT - BUSINESS ADVISORY COMMITTEE (BAC) - 2024

A detailed report of Entrepreneurs/Startups (E/S) funded is as follows: The statement provides information on:

- The E/S funded year-wise are: four in 2022; five in 2023; one in 2024.
- Six E/S who have fully repaid the funds are not mentioned in the Report.
- The funds to be repaid by twelve E/S amounts to Rs. 96,44,385.00
- The funds already repaid amounts to Rs. 95,55,615.00
- The Bank balance as on December 9, 2024 is Rs. 1,34,32,297.00
- The BAC Corpus, when we started funding, was Rs.1,65,00,000.00.

As a tribute to our past President, Mr. Minoo Shroff, (who passed away in April 2024 at the age of 95 years), Capt. Percy Master, Global President, had suggested that the BAC Fund for E/S, should be named as "Minoo Shroff Memorial Fund" (MSMF), which was approved by the India Region Board. Select members were asked if they would like to contribute to the MSMF. The contribution received so far is Rs.60,00,000.00.

What is of concern is the fact that in this year we have funded only one E/S – Dr. K. Dadachanji, owner of Sparkle Dental Care. We need to have four to five E/S for funding each year. The BAC had a meeting on October 9, 2024 to determine what action should be taken to promote Entrepreneurship within the Community. The following action steps were determined:

- a) To inform Members to keep their eyes and ears open to locate potential Entrepreneurs/Start-ups. Members need to know the BAC's first step in mentoring E/S seekings Funds. The first Note to E/S is attached which helps E/S with information on starting or growing a business.
- b) To get potential Entrepreneurs/Start-ups by advertising in the Social Media. A brief write-up was made for Social Media and given to Mr. Yazdi Tantra for circulation in Social Media. After publishing the write-up, two Applicants have responded seeking funds. One of them we have declined because he does not comply with our Policy requirements. One is under consideration (Mr. Eric Naverawalla).
- c) To create an interest within the Community, for promoting Entrepreneurship, we have recently made four videos on young entrepreneurs whom we have funded. The video on their success stories will be put on Social Media sites and the WZCC website.
- d) Mr. Adi Siganporia will shortly give a write-up on WZCC's efforts on mentoring Young Entrepreneurs/Start-ups and Professionals, for the Parsi Press and Magazines.

## ZARATHUSHTI ENTREPRENEURSHIP DEVELOPMENT FOUNDATION

#### **NARRATIVE OF 2024 ACTIVITIES**

The Zarathushti Entrepreneurship Development Foundation (ZEDF) was formed in 2021 as a 501(c)(3) not-for-profit entity to provide interest free loans to budding entrepreneurs. The complete 2023 Financial Report is attached. The activities for 2024 are listed below:

- Total donations collected to-date: \$599,000. Additionally, ZEDF has a formal committed agreement with the Ronnie and Shahnaaz Irani Foundation to receive the \$225,000 balance of their donation (\$25,000/year for the next 9 years).
- Total loan disbursements to-date: \$405,000.
- Nine (9) loans have been disbursed to-date:
  - 1) Suvio, LLC (manufacturer and seller of dietary supplements for muscle retention).

\$40,000 disbursed

- Fully paid off in January 2024 upon the divestiture of a majority stake to a new third-party investor.
- 2) Pariz Salon, LLC (upscale Hair Beauty Salon). \$50,000 disbursed
  - Paying back on schedule, current balance \$21,000.
- Grizzlies, LLC (boutique restaurant specializing in Pastrami-based foods). \$50,000 disbursed
  - Not paying back on schedule. Is on a payment plan to repay \$100 monthly, current balance \$43,000.
- 4) All City Embroidery (commercially embroiders logos, etc. on wearing apparel such as caps and shirts). \$50,000 disbursed
  - Paying back on schedule, current balance. \$42,000.

- 5) Agenome LLC (develops liquid biopsy-based diagnostics for lung and other cancers). \$50,000 disbursed
  - Paying back on schedule, current balance. \$44,000.
- 6) ZEDF Scholar: In 2022, ZEDF initiated a \$30,000 loan initiative for students pursuing a Master's degree with a major or focus in Entrepreneurship. A maximum loan of \$15,000 to an individual can be disbursed and repayments will start within four (4) years starting six (6) months after graduation. In September 2023, ZEDF disbursed \$15,000 to Layla Mazdyasni.
- 7) CA Dental and Medical CPA, Inc: (CPA services to medical professionals). \$50,000 disbursed.
  - Paying back on schedule, current balance. \$48,000.
- 8) Orian Gamete Ltd: (sperm and egg banking). \$50,000 disbursed in July 2024.
  - Repayments will start in January 2025.
- 9) Shahzadi Capital LLC: (owns and manages real estate). \$50,000 disbursed in November 2024.
  - Repayments will start in May 2025.
- Cash, cash equivalents and investments balance as of December 31, 2024: \$297,000.
- Loans receivable as of December 31, 2024: \$312,000.
- Other Applicants: We have three interested individuals but formal applications with accompanying business plans are still pending at the time of this report submission. (In general, the applicant pool is growing but it has been less than anticipated).
- Trustee Meetings: The Trustees met formally at five (5) meetings during 2024. At each meeting, at least the following items were discussed:
  - o Donor pipeline
  - o Treasurer's Report, including:
    - i. Current Donations to ZEDF and encouraging more in future years
    - ii. Bank and investment balances
    - iii. Income earned on investments
    - iv. Appreciation/depreciation in the value of investments and if any changes in the existing investment portfolio are needed
    - v. Status of loan applications and loan repayments
    - vi. Filing status of the annual Federal and State returns
    - vii. Meetings of the ZEDF Business Advisory Board
  - Opportunities for marketing ZEDF to encourage donations & applications
  - Strategizing ways to secure and encourage more applications
